1 Introduction

- 1.1 This Privacy Policy (together with our terms of use and any other documents referred to in it) explains what we do with your personal data.
- 1.2 It describes how we collect, use and process personal data, and how, in doing so, we comply with our legal obligations.
- 1.3 We respect your privacy and are committed to protecting it through our compliance with applicable privacy and data protection laws and regulations. Please read this privacy policy carefully to understand our policies and practices regarding your personal data and how we treat it. [Who Are We?]

- 1.7 The Crownville Ltd Service ("Captain Sport") is owned and operated by Crownville Ltd, a company registered in England and Wales with Company No 04248856 ("Crownville Ltd", "we", "us" or "our"). Our registered office is at 17 Bourne Court, Southend Road, Woodford Green, IG8 8HD
- 1.8 For the purposes of the UK Data Protection Act 2018 and the General Data Protection Regulation (Regulation (EU) 2016/679)) ("GDPR"), in respect of Crownville Ltd's Captain Sport service, we are the data controller. We are responsible for the processing of any personal data you provide to us whilst using our services.

2 When This Privacy Policy Applies

Captain Sport.

- 2.1 This Privacy Policy applies to personal information that we collect whilst you are using the Crownville Ltd and in any email and other communication between you and us.
- 2.2 It does not apply to information collected by any other website or web-based service operated by us (or our group companies), any website operated by a third party including those operated by the merchant that referred you to the Crownville Ltd or any third party application or content (including advertising) that may link to or be accessible from the Captain Sport website.
- 2.3 Please check the privacy policies of any external site before submitting any personal data to them, as we cannot accept any responsibility or liability in relation to them.

3 Why does Crownville Ltd Limited need to collect and store personal data?

3.1 We collect information in order to provide a tipster service to consumers over the phone.

4 Personal Data we collect and how we collect it

- 4.1 In order for us to provide our tipster services to you we need to collect limited personal data from you for identification purposes. In any event, we are committed to ensuring that the information we collect, and use is kept to a minimum, is appropriate for this purpose and does not constitute an invasion of your privacy. Crownville Ltd does not collect or process sensitive personal data.
- 4.2 Data we collect directly from you via the telecommunications systems when you use our service:

- 4.3 Data collected automatically
- 4.3.1 When you access our web-based services, we may also receive information automatically which relates to your computer, mobile device and internet connection, whether you decide to use our services or not. This includes your internet protocol address ("IP address"), your country of location, operating system, browser and platform type and access times. These are not actively utilised by the service and are only present in log file for technical operations and maintenance purposes. These log files are automatically deleted after 3 months.
- 4.3.2 Our website uses cookies which are small files of letters and numbers that we put on your computer. These cookies allow us to distinguish you from other users of our website, which helps us to provide you with a good experience when you browse our website and also helps us to improve our website. We use analytical cookies which enable us to recognise and count the number of visitors and to see how visitors move around our website. This helps us to improve the way our website works.

We currently use the following types of cookies.

5 Consent

5.1 Crownville Ltd does not collect or process sensitive personal data.

6 Will Crownville Ltd share my personal data with anyone else?

- 6.1 We may disclose your personal data if we are required to do so by law, any applicable regulation or to protect the rights, property, or safety of ourselves or others.
- 6.2 Crownville Ltd will not pass on your personal data to any other third parties. We do not pass the personal data you provide to us.

7 How will Crownville Ltd use the personal data it collects about me?

7.1 Crownville Ltd will process (collect, store and use) the information you provide in a manner compatible with the UK Data Protection Act 2018 and the GDPR. We will endeavour to keep your information accurate and up to date, and not keep it for longer than is necessary. Crownville Ltd is required to retain information in accordance with the law, such as information needed for income tax and audit purposes. How long certain kinds of personal data should be kept may also be governed by specific business-sector requirements and agreed practices. Personal data may be held in addition to these periods depending on individual business needs.

8 How long will Crownville Ltd keep the personal data it collects about me?

8.1 Crownville Ltd will process personal data only for the time required to complete the tipster process and once this is complete we will store the personal data for a period of two years in order to provide customer service, maintain an audit trail and comply with our legal and regulatory requirements.

9 Under what circumstances will Crownville Ltd contact me?

9.1 Our aim is not to be intrusive, and we undertake not to ask irrelevant or unnecessary questions. We will not normally contact you once our tipster service is complete. Moreover, the information you provide will be subject to rigorous measures and procedures to minimise the risk of unauthorised access or disclosure.

10 Your Rights as a Data Subject

- 10.1 At any point while we are in possession of or processing your personal data, you, the data subject, have the following rights:
 - Right of access you have the right to request a copy of the information that we hold about you.
 - Right of rectification you have a right to correct data that we hold about you that is inaccurate or incomplete.
 - Right to be forgotten in certain circumstances you can ask for the data we hold about you to be erased from our systems.
 - Right to restriction of processing where certain conditions apply to have a right to restrict the processing.

- Right of portability you have the right to have the data we hold about you transferred to another organisation.
- Right to object you have the right to object to certain types of processing such as direct marketing.
- Right to object to automated processing, including profiling you also have the right to be subject to the legal effects of automated processing or profiling.
- Right to judicial review: in the event that VeriMe Limited refuses your request under rights of access, we will provide you with a reason as to why. You have the right to complain as outlined below.
- 10.2 If you would like to exercise any of these rights, details of how to contact our Data Manager can be found at the end of this policy. In order to assist you with exercising these rights we will first need to confirm your identity.

11 How to Complain

11.1 Crownville Ltd takes complaints very seriously and will respond to complaints within 30 days, this allows us time to investigate your complaint thoroughly. In the event that you wish to make a complaint about how your personal information is used by us please contact our Data Manager.
